NF3 is stable at room temperature, but decomposes violently at 800~1200 ; NF3 is a potential oxidant, especially at about 200 , its reactivity is equivale nt to that of oxygen; NF3 is mainly used as a fluorination agent when it reacts with other elements; NF3 does not react with water, dilute acid and dilute alk ali solution at room temperature, but slowly hydrolyzes to form nitrite and flu orine when it contacts with alkaline solution at 100 Chemical, NF3 can react violently with water under the action of electric spark; NF3 can react rapidly with H2 or hydrides and release a lot of heat, which is the basis of NF3 used in high energy chemical lasers; NF3 can interact with organics, but it usually needs to raise the temperature to initiate the reaction, so it often explodes; when the temperature is lower than 70 , NF3 gas does not corrode ordinary met als, so steel and stainless steel can be used Nickel, copper, aluminum and othe r materials manufacturing related equipment.
